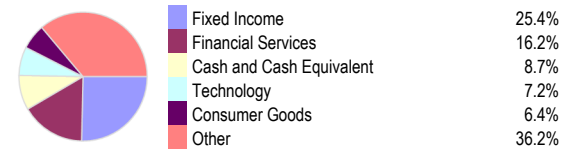
ASSET ALLOCATION

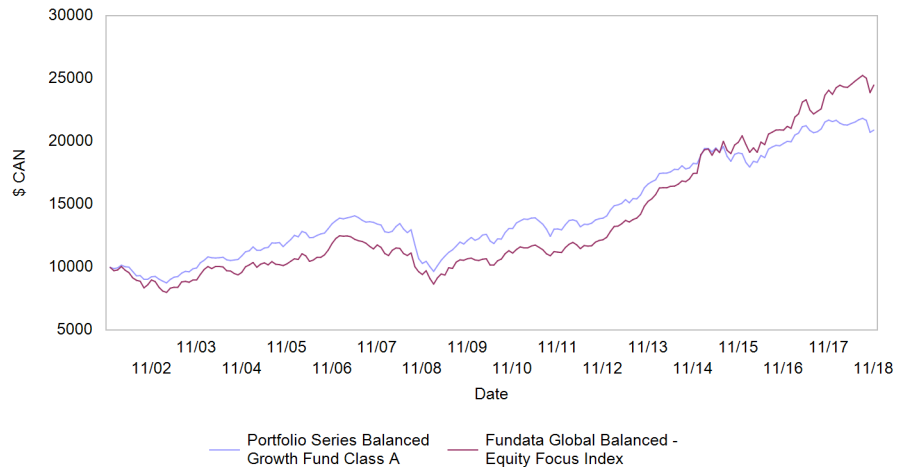
