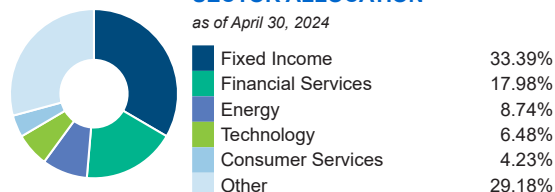
ASSET ALLOCATION
