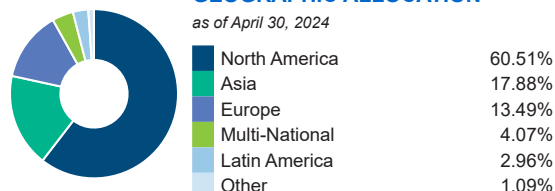
SECTOR ALLOCATION
