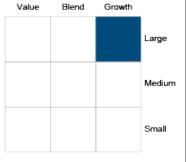
GEOGRAPHIC ALLOCATION

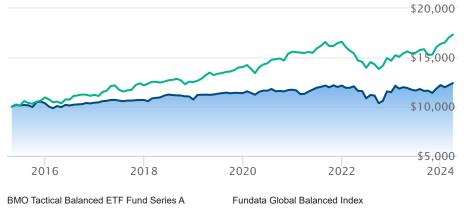
