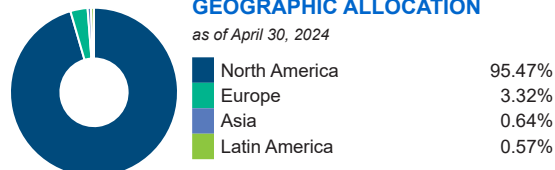
SECTOR ALLOCATION
