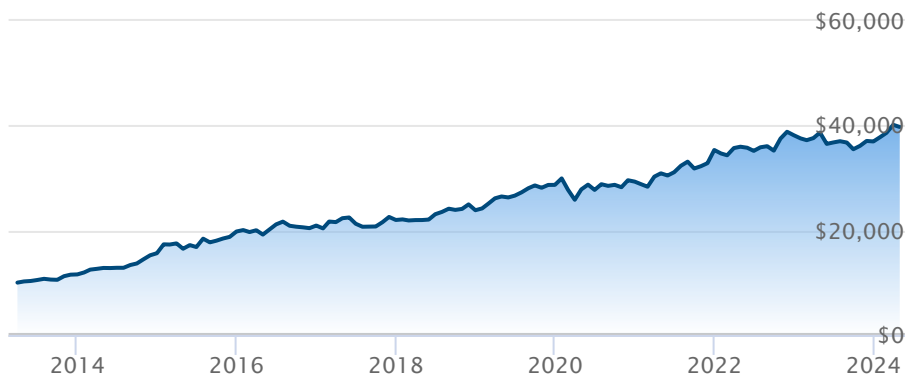

GROWTH OF \$10,000

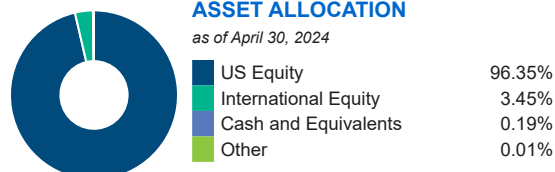
Annual values as of April 30, 2024

as of April 30, 2024



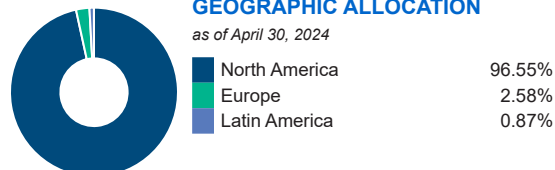
SECTOR ALLOCATION
